Tribal Health Literacy Summit: Navigating Pandemics Together

The Arizona Advisory Council on Indian Health Care and its COVID-19 Health Disparities Grant Team is pleased to announce the "Tribal Health Literacy Summit: Navigating Pandemics Together."

The three-day conference will be held from March 12-14, 2024, at the Desert Willow Conference Center in Phoenix, Arizona.

This event will bring together tribal leaders, healthcare professionals, policymakers, educators, and community advocates to address the challenges posed by pandemics and promote health literacy in Indian Country.

It is designed to tackle critical issues related to health literacy, chronic disease management, social determinants of health, health screening, prevention, and the foundations of health literacy within tribal communities.

In addition, there will be discussions on topics such as long COVID, food access, post-COVID mental health, and more. The primary goal is to equip tribal community members with the knowledge, information, and advocacy skills needed to address health disparities, especially in the context of the ongoing COVID-19 pandemic.

American Indian Health – AHEC Advisory Council Inauguration

The American Indian Health - AHEC Advisory Council held its inaugural meeting

this past January to manage the path of the AIH-AHEC program and its 3-year Strategic Plan implementation. The AIH-AHEC Advisory Council is a sub-counsel of the Arizona Advisory Council on Indian Health Care which was established in 1990.

The primary focus of AIH-AHEC is to address the specific healthcare workforce shortages within American Indian Health Care facilities across Arizona along with enhancing the professional development of the current healthcare workforce within our 22 Tribal Nations. The AIH-AHEC Advisory Council represents a diverse group of individuals recognizing the importance of assembling a diverse and knowledgeable Counsel representing Arizona higher educational institutions, Tribal Health Care facilities, and community organizations.

The AIH-AHEC Advisory Council members are; Agnes Attakai MPA, Native Initiatives, Sonoran Center for Excellence in Disabilities; Michael Darragh, MD, San Carlos Apache Health Care; Navaz Dolasa, MD, Gila River Health Care; Holly Figueroa, Arizona Rural Health Association / BCBS; Timian Godfrey, DNP, APRN, FNP-BC, University of Arizona College of Nursing; John Molina, MD, Arizona Advisory Council on Indian Health Care; Kim Russell, Navajo Department of Health; and Lillian Smith, DrPH, MPH, Northern Arizona University. The AIH-AHEC Advisory Council is currently pursuing additional members for the Council, to provide a well-rounded, Statewide representation.

The AIH-AHEC just completed their first 3-Year Strategic Plan in which the Advisory Council's role will be accountable for overseeing the planned objectives and ensuring success in its overall operations. The Advisory Council will also serve as a path to other organizations and Tribal communities as the program attempts to reach out to all 22 Arizona Tribal Communities. CDC-CCR Updates

As the CDC-CCR *CHRs WITH uS!* grant enters its last year of the grant cycle, the main goal is to strengthen the sustainability efforts of the Community Health Representative (CHR) workforce. The CDC-CCR team is working to continuously provide technical assistance in planning training events, grant partner meetings, and other events beneficial to the CHR Grant Partners. One of the sustainability efforts that the team has been working on is ensuring that every CHR applies for the Community Health Worker Voluntary Certification.

Bill Update: SB 1037 AHCCCS Comprehensive Dental Services

All AHCCCS (Medicaid) Members

Sponsor: Rep. T. J. Shope

<u>Summary:</u> This bill, if passed, would authorize AHCCCS to seek CMS approval to reimburse for preventative dental services up to \$1000 per member per benefit year (October 1 to September 30 of each year). Currently adults, 21 years of age and older, receive adult dental benefits only in the form of emergency services, up to \$1000 per member per benefit year. This bill, if passed by both Chambers and signed into law by the Governor, and if it makes it into the budget, would authorize AHCCCS to request CMS approval to update their current waiver they operate under to include this dental benefit.

Of interest to indigenous peoples and tribal providers, this would include no monetary cap for preventative dental services provided to American Indians and Alaskan Natives (AI/AN) who receive their preventative dental care via an Indian health care dental provider that receives 100% FMAP (e.g. IHS and 638 providers that meet necessary requirements, such as operating within the "4 walls" if applicable) for the cost of dental services in excess of limits in place for if this bill is approved.

<u>Status:</u> This Senate Bill was heard in the **Senate Health and Human Services** Committee on Tuesday, January 23rd, 2024. Representatives from the Oral Health Coalition and the Arizona Advisory Council on Indian Health Care (Dr. John Molina and Alison Lovell) were in attendance in support of the bill. It passed this committee.

It then was heard at the Senate Appropriations Committee on Tuesday, January 30th, 2024. Representatives from the Oral Health Coalition and the Arizona Advisory Council on Indian Health Care (Dr. John Molina and Alison Lovell) were in attendance in support of the bill. It passed this committee as well.

Next, we must see if this bill is added to the agenda for the Senate Rules Committee for a similar discussion. If this passes through the Senate Rules Committee, it would be cleared for consideration by the full Senate. However, there is a possibility that it may be held back by the Senate as a part of budget negotiations.

Arizona Oral Health Coalition

AZOHC emerged from the coordinated effort of multiple organizations and stakeholders who were concerned about the state of oral health in Arizona and the lack of cohesive action to address disparities. In 2015, advocates and leaders held a policy workshop to discuss oral health, which led to the Arizona Oral Health Steering Committee. The Steering Committee participated in the development of the AZ State Oral Health Plan. Ultimately, the Steering Committee became the Arizona Oral Health Coalition in 2016. In 2020, the Coalition underwent multiple structural changes, including reorganizing committees, updating the strategic plan, and completing equity assessments.

They have created a fact sheet to break down the value that SB 1037 can bring.

Acronyms and Definitions

Did You Know? AHCCCS has a published Contract and Policy Dictionary and a listing of Commonly Used Acronyms!

Have you ever been reading an article on Medicaid, or attempting to review one of the many documents on the AHCCCS website, and thought to yourself, "What on earth does that mean?" or, "What does that acronym stand for?"

Well never fear! AHCCCS actually has published documents to assist with both common questions:

- The AHCCCS Contract and Policy Dictionary is an actual dictionary of AHCCCS and Medicaid terms. It acts as a central location for definitions that you will see used in the various AHCCCS Contractors Operations Manual (ACOM) and AHCCS Medical Policy Manual (AMPM) Policies that are posted on the AHCCCS website. These terms are important to know, as they will help in your understanding of things like coverage and benefits, eligibility criteria, and MCO requirements.
- This Contract and Policy Dictionary is in the process of being hyperlinked within all policies found in both the ACOM and AMPM.
- Please note, that some policies have specific terms/definitions that may have a slightly different meaning for that respective Policy. When that is the case, those terms/ definitions will remain in the Policy and will include a statement indicating 'For purposes of this Policy only'.

• The AHCCCS Related Acronyms Reference Guide is a repository that defines any and all acronyms that you might see in various spots on the AHCCCS website, or when discussing Medicaid in general. Please keep in mind, that there are cases where AHCCCS uses an acronym a little differently than other states might.
