American Indian Health-AHECAHEC Scholars Two-Year Program

AHEC SCHOLARS TWO-YEAR PROGRAM

The Arizona AHEC Scholars Program (ASP) is a two-year interprofessional program for health profession undergraduate and graduate students. It is comprised of community-based experiential training conducted in rural and/or underserved settings in one of the Arizona AHEC Regions. The ASP builds from the Rural Health Professions Programs (RHPP) at the University of Arizona, Arizona State University and Northern Arizona University. Undergraduate and graduate students enrolled in Northern Arizona University Public Health and undergraduate Nursing programs are eligible and encouraged to apply. Priority will be given to Indigenous students focused on healthcare issues.

PROGRAM REQUIREMENTS OF AHEC SCHOLARS

- Assigned to an interprofessional team of health professions students from the three ABOR universities, a
 Faculty Mentor, and American Indian Health-AHEC (AIH-AHEC).
- Student must be enrolled and remain enrolled in and meet all academic and didactic training requirements
 of their respective health professional program.
- Commit to 80 hours each year for two years (didactic + community experiential learning).
- Participate in reflection, active learning and critical inquiry in a group setting with students from various health professions programs.
- Engage directly and indirectly with rural and/or underserved communities and guided by their Faculty Mentor and AIH-AHEC Regional Center Director and team.
- Learn about factors affecting the social determinants of health, cultural competency, behavioral
 health integration, practice transformation, inter-professional education, current and emerging
 health issues, connecting communities and supporting health professionals, and seek to improve
 virtual learning and telehealth training.

PROGRAM BENEFITS FOR AHEC SCHOLARS

- Develop an understanding that individual patients, families, communities and health providers are partners in shaping and delivering the educational experience.
- Progress in learning experiences reflective journaling; review community health needs assessments in
 published literature; review publicly available health information and reports; develop and administer
 surveys; collect, synthesize, and report data; present findings with data visualizations targeted to specific
 audiences, and make recommendations to improve individual and community health.
- Learn about collaborative relationships, engage in team-based care, and use interprofessional approaches
 to problems that include community agencies, patients, and health providers.



CHR Quarterly Meeting #4

AACHIC CHR Quarterly Meeting #4, August 20, 2024

The CDC-CCR team met at Cocopah Tribe (grant partner), Cultural Center.

There were 17 in-person and some virtual attendees. Tribal representatives from the six (6) Grant Partners from Hopi, Hualapai, Salt River, White Mountain Apache Tribe, and the Gila River Health Care were in attendance. Other guests were from the NAU evaluation team and the Colorado River Indian Tribes, CHR Program. The agenda included four presenters as well.



One speaker on the agenda was Mr. *Thomas Romard, IHS Public Health Nurse (PHN)*. Mr. Romard introduced himself and spoke of several areas as the PHN in Cocopah and Quechan. Thomas is new to PHN, from Canada. He spoke of the Fort Yuma Health Center (IHS) Mission. In his role as PHN for the Quechan and Cocopah Tribes, he elaborated on some specific areas he works within the communities, such as Outreach, Challenges, and Goals.



CHRs WITH uS! Grant Success Highlights (YR 3) Ashley Lazaro, Grants Manager, shared photos of previous CHR Quarterly meetings, CDC Site Visits, and the 2022 and 2023 CHR Summits. She also highlighted successes from the previous three years.

NAU-CHER Updates - Louisa O'Meara reported that they participated in the Tribal Community of Practice, organized and hosted by Envision since 2022. Several Arizona partners attended some of these meetings, virtually or in person at NACHW in 2023 or at the Envision Conference in April 2024.

With the end of the CDC-CCR grant, Envision is handling the Tribal CoP over to the participants. The others in this group currently are Mae-Gilene Begay and two evaluators who have been working with United American Indian Involvement in California. The NAU CDC-CCR also reported updates and discussion on the Digital Referral Tracker and Performance Measure Report they shared.

CDC-CCR Grant - Ashley covered the AACIHC CDC-CCR preliminary Work Plan & Goals for the final end grant cycle. Specific items she discussed are CHR Voluntary Re-Certifications Plans, Spending grant funds, and Training in focused areas. The Medicaid Billing Codes training is scheduled for September 26th by Alison Lovell, Business Operations Administrator at the AACHIC.

CHR WITH uS! Grant Partner Presentations - Several Tribal CHR grant partners shared a brief presentation about their CHR Programs and what they've accomplished throughout the grant years. Using PowerPoint, they shared information about program successes, current events and their plans for the 4th year as CDC-CCR grantee. The Tribes who presented are Cocopah, Gila River Health Care, WMAT, CRIT, and Hualapai.

CHR Workforce Strategic Plan - Mckayla Keams shared the agenda items, the goals, and the outcome for the strategic planning event, which was scheduled on 8/26/24.

The Quarterly meeting was a success and the meeting adjourned at 4:00PM.

Workshop Overview:

This workshop is the culmination of the work initiated by the COVID-19 Health Disparities Grant Team. After successfully hosting the first-ever **Tribal Health Literacy Summit** in spring 2024, we received valuable feedback that shaped our subsequent initiatives. In response, we launched the **Closer-to-Home Series**, which allowed our team to engage directly with tribal communities, providing on-demand health education, distributing infographics, and developing **Tangible Tribal Toolkits**. These toolkits were designed to promote health literacy interactively and engagingly, igniting a desire to learn about health and wellness across communities. Earlier this summer, we expanded our reach by introducing an **Online Virtual Training Series** in partnership with the **Arizona Advisory Council on Indian Health Care**, furthering our commitment to health education.

With our grant wrapping up on **December 31, 2024**, this workshop is our **final in-person learning opportunity** under the COVID-19 Health Disparities Grant. It represents our dedication to providing a meaningful and practical learning experience for the community members who have supported our efforts over the past year. We invite you to join us for this hands-on workshop, which focuses on three key areas:

- Health Literacy: Gain practical experience in how it affects patient outcomes and communication with healthcare providers.
- Patient Advocacy: Develop skills to champion patient rights and effectively interpret basic healthcare information from a patient's perspective.
- Role of Data in Health Disparities: Learn how data influences health outcomes and strategies to combat disparities, through storytelling.

Our Intention:

As we approach the conclusion of our grant, this workshop is designed to offer a hands-on learning opportunity and apply the work of the COVID-19 Health Disparities Grant; this is not only a learning experience but also a celebration of the collective progress we have made in promoting health literacy and addressing health disparities in Arizona's tribal communities. By equipping attendees with practical knowledge and tools, we aim to foster stronger, healthier communities that can continue to thrive long after the grant concludes. Together, we will work to ensure lasting, impactful change in health literacy and advocacy.

Our technical support series is designed by subject matter experts in their fields. Individuals with years of experience either working in things like billing, provider training, health and wellness fields, or with experience in clinical settings and vaccine clinics, all play a role in the creation of our trainings.


